1. Apologies

He asked what the Council's position might be to any future planning application for such access? The Chairman replied that she couldn't predict what the opinion of the Council might be to a future application.

- **b.** Cycleways The Clerk reported that the application to use CIL to fund improvements to the ROW from Cocking Hill down into the village had been submitted.
- **c.** Speedwatch Cllr D Imlach reported that the new person in charge at Sussex Police said a restructuring was planned, and he was happy to come to Cocking to assist volunteers get started.
- d. Traffic calming WSCC had responded to the Parish Council's request for additional repeater signs through the village, by proposing two roundels painted on the road. Members were pleased to support the suggestion. The Clerk reported that WSCC were not willing to look again at suggested locations for the proposed portable SID; Members remarked that until such time that funds were in place there would be little merit in arguing the point.

11. Updates on Parish Matters

- a. Playground Cllr D Imlach was progressing minor items raised in the annual ROSPA report, including jet-washing and painting.
- b. Village Hall quotes still being sought to get new fire door fitted.
- c. Other The bench at Crypt Lane had collapsed. A window had been replaced at the bus shelter and some hanging baskets added!
